A: SUMMARY OF EXPERIENCE

In these two pages of highlights, I address each key point in your job description.

RESEARCH AND SCHOLARSHIP

My field of research is urban morphometrics (techniques of measuring urban form). I use City Information Modelling (CIM, the city-scale version of BIM) and GIS to investigate the relationships between urban morphology and urban design on the one hand, and socio-economic and environmental outcomes, on the other. Prior to joining the University of Hong Kong in 2016, I was at Cardiff University where since 2011, I have focused on developing and testing sDNA (spatial Design Network Analysis), a software-based tool for analysing urban network shapes. sDNA is a freeware platform that enables spatial network research. sDNA PLUS is the licensable version. Since 2011, 10 research projects worth £1m+ (not including commercial income) have used sDNA, including the project that won the 2014 Royal Town Planning Institute (RTPI) Research Award.

Prior to joining Cardiff University in 2011, I was Board Director at Space Syntax Limited, the pioneering research-based consultancy in the technical field of spatial network analysis, and a knowledge-exchange spin-out company of the Bartlett, University College London (UCL). Over 10 years there, I was responsible for more than 50 consultancy and academic research projects worth £3m+ and over 40 practical urban design and planning policy projects totalling £1.3m. This work was underpinned by academic research carried out in conjunction with UCL, where I was Honorary Research Fellow. During this time, I was PI on a £1.2 million research project, 'i-VALUL: The socio-economic value of urban layout', hosted at UCL, and was Co-I on 3 other projects totalling £1.2m, hosted at UCL, University of East London and Oxford University. I am an internationally-recognised expert in spatial network analysis, and have served as expert peer reviewer on research grant-funding bodies of 5 countries. Building on this, I am currently working towards a PhD by publication.

I am named author on 126 research outputs, and over 230 citations since 2010.

These outputs **demonstrate my ability to conduct academic research** and reflect my career path which can be divided into three distinct phases: (1) 2011- present: 4 years as **full-time academic** Cardiff University, (2) 2000-2009: 10 years in **academic research-related consultancy**, Space Syntax Ltd; (3) 1986-1999: 14 years combining teaching, research by design and architecture and art practice at the Architectural Association (AA)¹. There are five peer reviewed publications since I have only been in full-time academia for 4 years. Prior to that, while I conducted and led academic research, my primary role was to create and realise opportunities for research, and my primary output formats were articles in professional journals and conference papers.

At Space Syntax Ltd, as director, I **attracted funds** and **managed projects** worth on average £250,000 a year, from mixed funding sources which included public and private sector funding, and academic research grants. Of note, I won **£1.2 million** for the i-VALUL project. Since working in full-time academia in 2011, my work and grants held has focused on developing and testing of sDNA as a platform on which project or research can be conducted. Grant income based on sDNA totals £387,000 of which: £105,000 as PI, £282,000 as Co-I.

My research interests, technical achievements in advanced digital technologies, practical experience in built environment design, understanding of both design and urban economics, and of the aesthetic and technical aspects of design, could help HKUrbanLab realise its interdisciplinary ambitions. In particular, I will be able to make substantial contributions to research on high density cities, especially

where the use of big data and software innovations are key (BIM-GIS-GeoDesign); sDNA is already used in the Healthy HD Cities research centre.

TEACHING AND LEARNING

I have a **26-year track record of university teaching experience**, especially in design **studio teaching**² mainly in France and the UK, with visiting positions in the USA, Netherlands, Germany, and Finland. Of note, I taught at **the AA for 8 years**, was **external examiner** at Ecole Nationale Supérieure d'Architecture Toulouse and from 2011, been instrumental in **re-shaping the Cardiff MA Urban Design (MAUD) curriculum**³, currently the largest such programme in the UK. I have **developed curricula** for design studios at Cardiff, the AA, at University of Westminster, Kingston University, and the University of the Arts in London. I have also led and developed many international design workshops, including at Harvard and Columbia Universities in the US and the Berlage Institute in Amsterdam. I have supervised **over 700** postgraduate and undergraduate **design theses or dissertation** projects. My students' work has won national prizes, including the **Royal Institute of British Architects' (RIBA) Bronze Medal** and **Royal Academy prizes**. It has also been published in over many countries, and exhibited internationally, including at the **Venice Biennale**.

Teaching highlights in the three phases of my career include: (1) 2011- present at Cardiff University: Lead 2 modules (amounting to 50 credits including a design studio) on MAUD, and 20-credit module in MSc Eco-Cities. Teach on a further 2 modules. I teach annually at Tongji University in Shanghai where I am Visiting Scholar. I also teach at Westminster University in London. I have **supervised 3 PhD students**, **2-3 postgraduate interns** annually, and about 6 **MAUD research-based design projects**; (2) and (3) 1989 – 2010 alongside professional consultancy and design practice, taught in three studio-based discipline related across the spatial scales: Interior Architecture, Architecture and Urban Design at undergraduate and postgraduate levels. This includes at the **AA** and at the **London School of Economics (LSE)** and **Ecole Nationale Supérieure d'Architecture, Grenoble, France**⁴.

At Cardiff, I have focused on **providing academic leadership** in **evidence-based urban design**, and **ensuring that insights from the fast-growing field of urban design research inform urban design education**. In the Cardiff MAUD, I **developed a 'high density living' design studio** which essentially engages student in research 'for design' and 'research by design'. Students systematically evaluate their design options, **innovatively incorporating property and public good valuation exercises within the design studio** itself. At the AA, I **developed methodologies** that include a 'form to programme' approach, a 'strong scaffolding' methodology, and the use of 'complex games' in architectural teaching. I have an excellent track record in **mentoring urban designers and planners**. For instance, two recent Erasmus programme **interns** have returned to their home universities (Cagliari and Rome Sapienza Universities) and **achieved top grades** in the work I guided them on.

I have wide experience of academic administration. My major recent contribution has been as admissions tutor for the Cardiff MAUD, where a change in admissions strategy has contributed to the growth that the University has sought; student numbers have doubled from 2014 to 2015, and are expected to grow by a further 50% in 2016-17.

SERVICE

Apart from dealing with admissions, I was **RICS coordinator** for the Cardiff School of Planning (CPLAN), where I have enabled a number of course accreditations in the past two years. **Knowledge transfer** activities at Cardiff and Space Syntax Ltd have been covered in 'Research and Scholarship' as much of my research is applied. I have often made **contributions to the strategic management** in CPLAN, including developing a student workload model.

sDNA is a strategic Land Use and Transport Interaction (LUTI) modelling environment with the originality of taking into consideration the complete network, instead of skeleton network. It is used at early urban planning and design stage to macro-micro locate land use type and their intensity. Accounting for the relationship between land use and transport interaction through multi-scale accessibility analysis, sDNA enable designer to make design decision that despite a low level of data requirement are aligned with sustainable urban form objectives. Beyond this early design stage traditional LUTI can be used. In post processing LUTI model can be informed by sDNA output:

- a. to explicitly take into account of the geometry of the urban environment whether existing or planned (2D, 3D) over time and compare values vs cost.
- b. to account for pedestrian, cyclist (sustainable mode of transport) along with car driver behaviour and public transport access points location in the same framework.

Space Syntax Limited is a spinoff company associated with University College London, where I was also Honorary Senior Research Fellow. During my work as director I focused on working with local authorities. Projects by Space Syntax Limited underpinned by the UCL research work, have informed the local plans, strategies and planning application processes of important projects for more than ten local authorities in the UK. Cardiff University

2. Since my appointment at Cardiff, I have had 4 years of successful applied research and knowledge transfer work on creating, developing and testing sDNA, a new methodological platform and software for spatial network analysis using codification and data model that complies to an

international standard. This was developed between September 2011 and early 2013. sDNA has since attracted £300,000 worth of funding for the University (contributing 81% of 2012-13 CPLAN RCUK funding, i.e. £198,297 from ESRC) enabled over 10 peer reviewed publications and 1 book. It is the basis of research that won the Royal Town Planning Institute national research prize in 2014, of research of at least 2 PhD theses. sDNA was the subject of the winning proposal in the Cardiff University wide i-Solve business entrepreneurship competition 2013-14, and was the main reason for the visit of the UK Cabinet Office Minister Francis Maude to Cardiff University in 2014. Since 2013, there have been more than 400 downloads of sDNA software, 75% international.

The IP registration of sDNA with Cardiff's RIS (Research and Innovation Services) recognise my status as 'inventor' of sDNA; I am the primary beneficiary of profit share from sDNA's proceeds *before* and above the other beneficiaries. This is evidence of the centrality of my role in creating sDNA and bringing it into Cardiff University, and in enabling sDNA's use so far, in various research projects.

Teaching innovations

'sDNA: Teaching with digital technology for urban networks'

I have worked with innovative digital technology in teaching starting with SimCity at the AA, the use of parametric sketching, a precursor of now current parametric design, at Kingston University and Greenwich University (See CV). I taught in the MA Digital Technology at Westminster University for more than 10 years (see CV). I continued my interest in digital technology while at Space Syntax, developing new techniques and services design (see Publications).

If the MA Urban Design is my primary focus in teaching, the sDNA is the focus of my research and innovation and engagement work (I&E). I also have considerable experience in advising urban planners and urban designers in the private and public sectors. sDNA is a software which I invented and was launched in 2013 as a methodological platform for research into spatial networks based on an international technical standard. sDNA provide is a tool to characterize places.

a. As with all good knowledge products, sDNA can be tapped for, not just research and I&E, but for teaching ends as well.

For teaching, in the past 2 years, the sDNA:

- b. Has been the basis for external international workshops (See CV), for which I have been invited.
- c. Training international interns
- d. Use in MA UD Development Management Module from this year.

It can potentially revolutionise the modelling of spatial networks, and importantly, the teaching of urban planning and design, because it allows disambiguated characterisation of places and the use of first principles to evaluate "what if" scenarios.

'VALUING DESIGN / DESIGNING VALUE in the design studio: Innovation in teaching'

The education of architects and built environment designers is, by its very nature, a training in methods of how to generate built forms creatively often via a studio pedagogy, that is dominant in built environment design including architecture, planning, landscape and urban design. "Studio pedagogy typically 'begins with an open-ended problem, often taking account of current issues in the "real world" with "real clients," and gives students some choice in their direction within the scope of the problem. This is follows a series of structured conversations between the instructor(s), students, and often, a collection of outside experts with knowledge specific to the problem under examination'" (Judith Grant Long, 2012)' (Chiaradia et al, submitted for publication).

When in 2011, I took over the Autumn Studio module (then known as Studio 1) in the Cardiff MA Urban Design, I applied the creative 'can do' attitude of studio teaching to the teaching of 'real estate valuation' to designers, within a design studio context.

Valuation within the Autumn Studio is innovative in a number of ways:

 a. A brief survey of all UK MA Urban Design courses indicates that this is the only module in the UK that relates design and valuation in this way, while only four of the other courses teach development appraisal / property valuation at all.

- b. Through a basic 'valuation' exercise, it engages students in, not just technically executing the valuation calculation, but in the consideration of social-philosophical issues which form the bedrock of urban design thinking the creation and destruction of private and public goods.
- c. Students are asked to value their own design proposals and to assess their feasibility. What is particularly innovative is that students are then asked to consider the modification of their design based on those valuations.
- d. A 'case study' approach to teaching is used, much like is done in management teaching. I collected extensive property and survey data, which is provided to the students, so that their efforts are expended, not on trawling the internet for data, but in engaging with the questions of value, both public and private, and their relationships to the design proposals.
- e. The development and refinement of this module since its inception has been commended by external examiners.
- f. The module has consistently achieved scores of over 4.3 from students' evaluation.

A peer-reviewed article "Learning Values in Urban Design: a studio based approach" has been submitted to a leading journal, which discusses the contribution of this approach to teaching, to the wider subject of urban design. The paper is undergoing revisions, but reviewers have described it as 'important'.

Admission tutor

1. 2013-present: MA Urban Design admissions tutor. As admissions tutor, a responsibility I have held since 2013, I have reduced the response time from 'indeterminate' (and often for as long as six months) to one week, noting that general choice theory states that delay may produce choice instability. Applications have increased by 12% from 367 to 412 in 2013 to 505 in 2014. While the increase may be also attributable to other factors, application-to-arrivals conversion rate has doubled from 7% to 13%. In 2014, the MAUD applications have increased by more than 20% while the rest of post graduate courses have increased by 10%. For the last 3 years the MA UD application represent 40% of all post graduate applications.

RICS coordinator

2. 2012- present: School (CPLAN) Coordinator for the Royal Institute of Chartered Surveyors (RICS). I am the point of contact between RICS and CPLAN. I attend RICS national meetings on behalf of the Head of School, coordinate the collation of information and the final editing of the submitted documents for the partnership meetings. Every year the document is praised for its organisation clarity. I was instrumental in facilitating course accreditations by RICS; the number of accredited courses has doubled since I took up the role. The annual renewals of accreditations have all been successful so far. In the interest of efficiency, the partners have agreed to my suggestion of reducing the numbers of partnership meetings from every year to three meetings every five years. To strengthen CPLAN and my professional and research network, I am in the process of applying for the status of Chartered Surveyor.

Periodic review

3. In 2014, I contributed to the CPLAN Periodic Review, which aimed to streamline some PGT modules. I designed an evidence-based approach for this, creating an EXCEL document containing all the details of CPLAN PGT module portfolio, organised by semester. This greatly facilitated the analysis, discussions and recommendations. The contribution was very thorough, timely, useful and well-received.

Student workload model

4. In 2012 I introduced at a CPLAN staff meeting, the idea of student weekly work load model to facilitate the discussion of student experience, especially in those courses where student workload is a particular problem. I have since discovered that such a tool does not exist in Cardiff nor in any of the other Russell group universities. This was recently well-received, and the Director of Learning and Teaching has committed to act on the results that the workload model has thrown up for the affected courses. This issue is particularly acute for design students. It has been taken on board by both CPLAN and ARCHI management.
